Director's Report

As you may know, the Adirondack Mountain Club recently had a statewide vote - which has since passed. It changes the structure of the main club's executive board and mission statement wording. The change making process has begun with several Zoom meetings where current board members were able to listen and ask questions. A review of the changes is currently being done by a separate organization to ensure all of the changes are legal. It is expected that the transition will take a long time - at least through next year. Some of the goals are to strengthen the communications between chapters, and between chapters and the main club, and to have the chapters more in sync with the main club's objectives and activities. I know from participating in the Volunteer Trailhead Steward program at the Loj this year that a large

population of Buffalonians are visiting the Adirondack Loj and Heart Lake property grounds - from the Adirondack Loj Trailhead, using the hiker parking lots, to staying at the Wilderness Campground. During my time there, I spoke with many, hoping we can get more people involved in our local chapter and the club in general.

There will be a process starting soon to look for new members of the main board. Anyone with a specific set of skills related to club activities, such as publications, hotel management, trails management, finance and education might make a good board member. The new board will have significant responsibility and will meet every month. Conservation Corner



During the November meeting, we discussed concern about what the potential plans by the Erie Canal Harbor Development Corporation might be for the Buffalo Outer Harbor. Currently Buffalo City and Erie County residents are able to enjoy the open space of the Outer Harbor for family walks, biking, fishing and wildlife watching. The area includes internationally important bird habitat for the birds to rest and feed during migration. The shoreline also provides vital habitat for fish to spawn. ADK-NFC is one of many groups who are advocating that the Outer Harbor should be kept as a passive recreational area in contrast to the Inner Harbor that has already been commercialized.

Recently there was a plan to install a large number of solar panels on Unity Island (formally Squaw Island) to power the Buffalo Water Treatment Plan. These plans were withdrawn when it was pointed out that this section of land is designated as parkland. ADK would like to see the land used passively such as sledding on the capped landfill hills in the winter and walking in the summer. It has wonderful views of the sunset across Lake Erie. Certain areas could be planted to encourage habitat for birds, butterflies and bees. The large grassy area is already perfect nesting and feeding habitat for Meadowlarks and Bobolinks. This area is also rich in local history. The Black Rock Historical Society should be encouraged to install signage of historical events that occurred in this area.

### **Statewide Conservation Issues**

Seth Jones, the Heart Lake Education Director, has been an active member of the High Peaks Advisory Task Force. The group has been developing recommendations on how to address over use in the Adirondack Park. ADK is focusing on education and improving trail infrastructure to help mitigate the effects of high use. The final report will be released by the end of 2020. The Governor's office has asked ADK to join the newly created Catskills Advisory Task Force.

The NYS Legislative session was shortened due to the pandemic. Bill A2655/S3392 was passed which classified fracking drilling waste as hazardous which eliminated a loophole that allowed it to be sent from PA to NYS for storage in landfills.

# Our Virtual Conservation Meeting:

The Conservation Committee will continue to use Zoom for monthly meetings – all are welcome!

The proposed 3 billion Restore Mother Nature Bond Act has been removed from the 2021 NYS Budget proposal due to state wide financial concerns caused by the pandemic. ADK will lobby for the bond act to be re-initiated when it is fiscally responsible to do so. The bond act encompassed many aspects

including ways to revitalize critical fish and wildlife habitats, waterway improvements, restoring freshwater and tidal wetlands, preserving open space and conserving forestlands.

ADK is advocating for the passage of the NYS Green Amendment which would guarantee that all NYS citizens shall have the right to clean air and water, and a healthful environment. This would be added to the NYS Bill of Rights. An amendment must be passed twice in two separate legislation sessions before it can be put onto the NYS ballot for a statewide vote. It was passed in 2019. ADK will be lobbying for it to be passed in the 2021 legislative session so it can be placed on the statewide ballot in 2022.

*ADK* is requesting a dialogue be initiated with the military at Fort Drum regarding their proposal for 126 days of low level helicopter training in the Adirondack Park.

11/09/20 - BIKE - 3 Lake Sunset


